Dear Colleagues and Friends,

On behalf of the ENMESH Board Committee, it is a great pleasure to welcome you to the XIth ENMESH International Conference in Málaga. You will have the opportunity to choose from about 500 contributions delivered by mental health services researchers from 30 countries from the 5 continents: 20 from Europe, 5 from America, 3 from Asia, 1 from Oceania and 1 from Africa.

This is an excellent response, better than expected, to our invitation to participate in this very important event about the thematic "Closing the gap between research and policy in mental health". This mix of cultures will allow the exchange of experience in both worldwide research and health management. New models of mental health services which are not only different but also complementary, will be presented which will allow us to breach the gap between research and policy of mental health services across continents.

In line with previous ENMESH International Conferences, general keynote lectures will consist of 5 plenary sessions which will be held by 10 experts from 7 different countries (Canada, Australia, Germany, United Kingdom, France, Portugal and Spain) concerning the four Conference Thematic Tracks: (1) Global mental health, (2) From epidemiological research to clinical implementation: a) From prevention to interventions; b) Novel services for mental health care. (3) Closing the gap between psychiatric care and primary care and (4) Mental health during an economic crisis.



We are also sorry that the daily timetable throughout the conference is so long.

We are grateful to all presenters for submitting their work, to the distinguished experts for accepting our invitations to give keynote speeches, and to the many colleagues who agreed to chair oral presentation or poster sessions. We give thanks to the Málaga University (Research Department and Psychology School), to the Spanish Society of Psychiatric Epidemiology, to Spanish Society of Neuropsychiatry and to the Mental Health Unit of the University Regional Hospital of Málaga for their support.

Finally, we are grateful to the Local and ENMESH Scientific Committee for their wonderful job in reviewing the submitted papers and in preparing the final version of the program. Finally, we thank the FASE 20 team, particularly to Neomar Betancourt, for their organizational work.

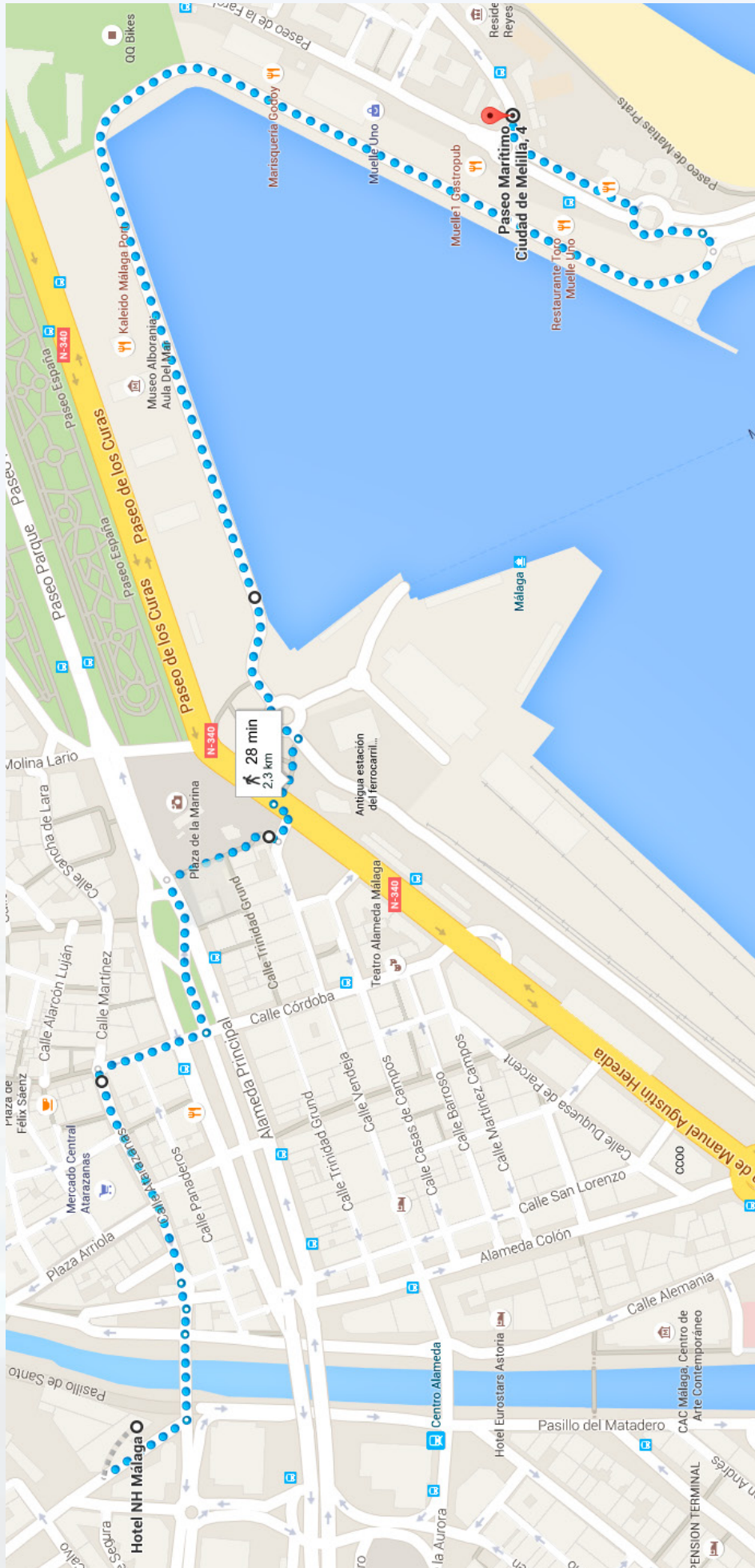

Málaga Useful Information

Banks

In the city center there are several banks open from 08:30 to 14:00 Monday to Friday. There are many ATMs 24 hours a day – 7 days a week.

Credit cards

In Spain all the main credit cards are accepted, but be sure to have some cash with you at all times because some small local business don't always accept credit cards.

Currency

The Spanish currency is Euro (EUR o €). The approximate exchange rate (August 2015) is:

1 EUR = 0.71509 GBP

Electricity

Spanish voltage is usually 220 or 230 volts and 50 hertz (*the voltage can vary under certain circumstances*). The electrical systems only accept the 2 pin round plug. The Spanish system is compatible with most European plug socket except mainly for the British 3 pin plug.

Language

Malaga is a popular tourist destination, so most of the restaurants and bar staff speak English.

Location and weather

Given Malaga's location on the Mediterranean, it has a comfortable climate year-round that is conducive to travel all the time. During May to October, you'll encounter less rain and beautiful 70-80 degree Fahrenheit days. The high season is during the summer when tourists from countries all over the world join local Europeans taking their annual summer vacation, making it a very busy place.

Opening hours

Depending on the location of the shops in Malaga they have different opening times:

- *Department stores and malls are normally open from 10:00 – 22:00 (Monday to Saturday).*
- *Small Shops (bakery's, newsstands, hairdressers...) are normally closed during lunch time from 14:30-17:30 (Monday to Saturday).*
- *Shops in Malaga center are normally open all day and close at 21:00 (Monday to Saturday).*
- *Restaurants normally open their kitchen at 13:00 and close at 0:00.*

Smoking

Smoking has been banned in Spain since the 2nd of January 2011. Smoking in enclosed public spaces is prohibited and open-air smoking is banned in children's play-grounds, parks and access points to schools and hospitals.

Taxes

The VAT Tax Rate in Spain stands at 21 percent.

Telephones

Spain's country code is 0034. For international calls, dial 00 + national code + area code + personal number.

Time

The Spanish local time is UTC (GMT) +1:00, that means one hour ahead of Greenwich mean time. Spain adopts the daylight saving time from the last Sunday in March till the last Sunday of October.

Tipping

In all restaurants, bars, taxis, etc. the service is included in the price. Tips are happily accepted but it is not necessary to leave anything more than the amount stated on the bill.

Getting around

As any big city, travel options around Malaga are abundant.

- Walking is possibly the best way to see the sites of Malaga. It allows you to take whichever route you want with as many stops as you want..
- Bicycles can be rented for a few hours, half a day or a full day (*prices may vary according to the hire company*).

Most bicycle hire companies will also give the option of a guided tour on your bike, either with your own party or in groups.

• Malaga city has a two-line metro system that runs from the center to the west and south-west of the city, starting from Maria Zambrano-RENFE train station.

- Public Transport by buses is very efficient. The buses are operated by a municipal company called EMT. Single tickets cost 1.30€.
- **Buses to other places:** *The bus station is located on Paseo de los Tilos. For information about the buses please visit www.avanzabus.com*

- **Car parks:** *There are a number of 24 hour car parks operated by the local council in key locations. The cost is about 2.50€ per hour and a max. of 20€ per day.*
- **Street parking:** *There is little street parking available in Malaga city especially during the working day. Blue road markings tell you the space is part of the local council (SARE) pay and display system. Find a machine nearby. Cost varies on location but is about 1€ per hour.*
- **Taxis:** *There are many taxi ranks throughout Malaga city. Saturdays are charged at the same rate as holiday taxi fares so they will cost more. Taxi fares also increase after 22:00 on week days and 21:00 Friday-Sunday. Rates begin at 1.68€ and each additional km is 89 cents or 1.03€ nights and weekends.*

The city of Málaga

More than 3,000 years of history have passed since the Phoenicians settled in Málaga transforming the beautiful, friendly and cosmopolitan city that enchants tourists from all over the world today. Málaga, capital of the province of the same name, is the fifth most populated city in Spain. It is located in the south of the Iberian Peninsula, in a privileged spot. The city covers 398.25 square kilometres and has a population of almost 568,000 inhabitants, although almost a million people live in the metropolitan area and had 3.5 million visitors last year.

Whilst the Mediterranean Sea bathes the Málaga coastline, the mountains surrounding Málaga close ranks behind the city to form a barrier of peaks protecting the city from the cold, while the regulating effect of the sea gives the area its well-known mild temperatures. The hottest months are July and August. December and February are usually the coldest. The average temperatures fall between a maximum of 22.8° C and a minimum of 13° C. Rainfall in Málaga follows the seasons, with the most abundant occurring in autumn and winter.

What to see in Málaga?

More than 3,000 years of history have passed since the Phoenicians settled in Málaga transforming the beautiful, friendly and cosmopolitan city that enchants tourists from all over the world today. "Málaga, Spain's Self-Appointed New Arts Hub" was published by The New York Times in March 24, 2015. The journal continues about Malaga as follows: "For the past 15 years, Málaga, the birthplace of Pablo Picasso, has pushed to promote its connection to the great painter, as part of its efforts to turn itself into an arts center. Now, the cultural ambitions of this city are taking on a new dimension, spearheaded by its longstanding mayor, Francisco de la Torre, who persuaded two prestigious museums to add here their first overseas offshoots: the Pompidou Center from Paris and the State Russian Museum from Saint Petersburg." Málaga already added two major institutions in 2003: a Picasso museum and a Center of Contemporary Art housed in a former wholesale food market. In 2011, the mayor convinced Baroness Carmen Thyssen-Bornemisza to move part of her collection — mostly 19th-century Spanish paintings — to a former palace here, within walking distance of the Picasso museum. "Málaga will now join the select group of cities that offers a complete art itinerary, from the seventeenth century to the truly contemporary," said Fernando Francés, the director of the Contemporary Art Center.

The Roman Theatre and garum (Roman fish paste) pools will transport you back to the times of Roman Hispania. Meanwhile, the Alcazaba is the most beautiful living example of the period of Muslim domination. Experience the Reconquest (La Recon-

quista) by the Catholic Monarchs from the Santuario de la Victoria (the Sanctuary of Victory); or stroll along Calle San Agustín, formerly known as the Calle de los Caballeros, (the Street of the Knights) since they settled on this street, with the Palacio de Buenavista as its most significant feature.

• PUENTE DE LOS ALEMANES: (The Bridge of the Germans)

The Santo Domingo Bridge, popularly known as the Bridge of the Germans, was gifted to the city of Málaga by the German people in gratitude for the people of Malaga's help when the German vessel, the Gneisenau, was wrecked.

A steel bridge built in 1909, it was moved in 1992 to ensure it formed an angle of 90° with regard to the Santo Domingo Church. The story goes back to December 1900 when a storm wrecked the German frigate Gneisenau. Many residents came to the rescue of the sailors and some of the rescuers lost their lives in the attempt. This heroic episode earned the city the title of "Very Hospitable", a slogan that appears on the city's coat of arms. Years later, in 1907, the Guadalmedina river overflowed its banks washing away the bridges. On hearing this news, the German people decided to return the favour and started popular collections to build the "Bridge of the Germans."

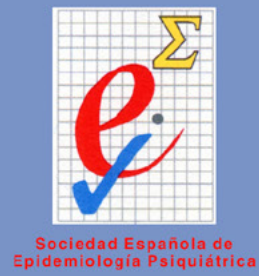
